Motion 01 Motion Passed December 28, 2019

Motion by Brother Bruce Frail to donate \$100.00 in the name of Brother Partington PC-in-C to the GAR Hall in Philadelphia, Pennsylvania. To come from the General Fund, seconded by Brother Kevin Martin.

Motion 02 Motion Passed February 21, 2020

Motion by Brother Bruce Frail to donate \$100.00, from the General Fund, in the name of Brother Lowell V. Hammer PCinC to the Sons of Union Veterans Charitable Foundation, seconded by Brother Kevin Martin.

Motion 03 Motion Passed March 23, 2020

Motion by the Department of the Chesapeake to change the dates of their encampment from May 8th and 9th to just May 9th.

Special Vote Passed March 26, 2020

Request by the Nebraska and the Dakotas to change the date of their encampment from April 25th to June 20th.

Motion 06 Motion Failed May 21, 2020

Special Vote Passed August 17, 2020
