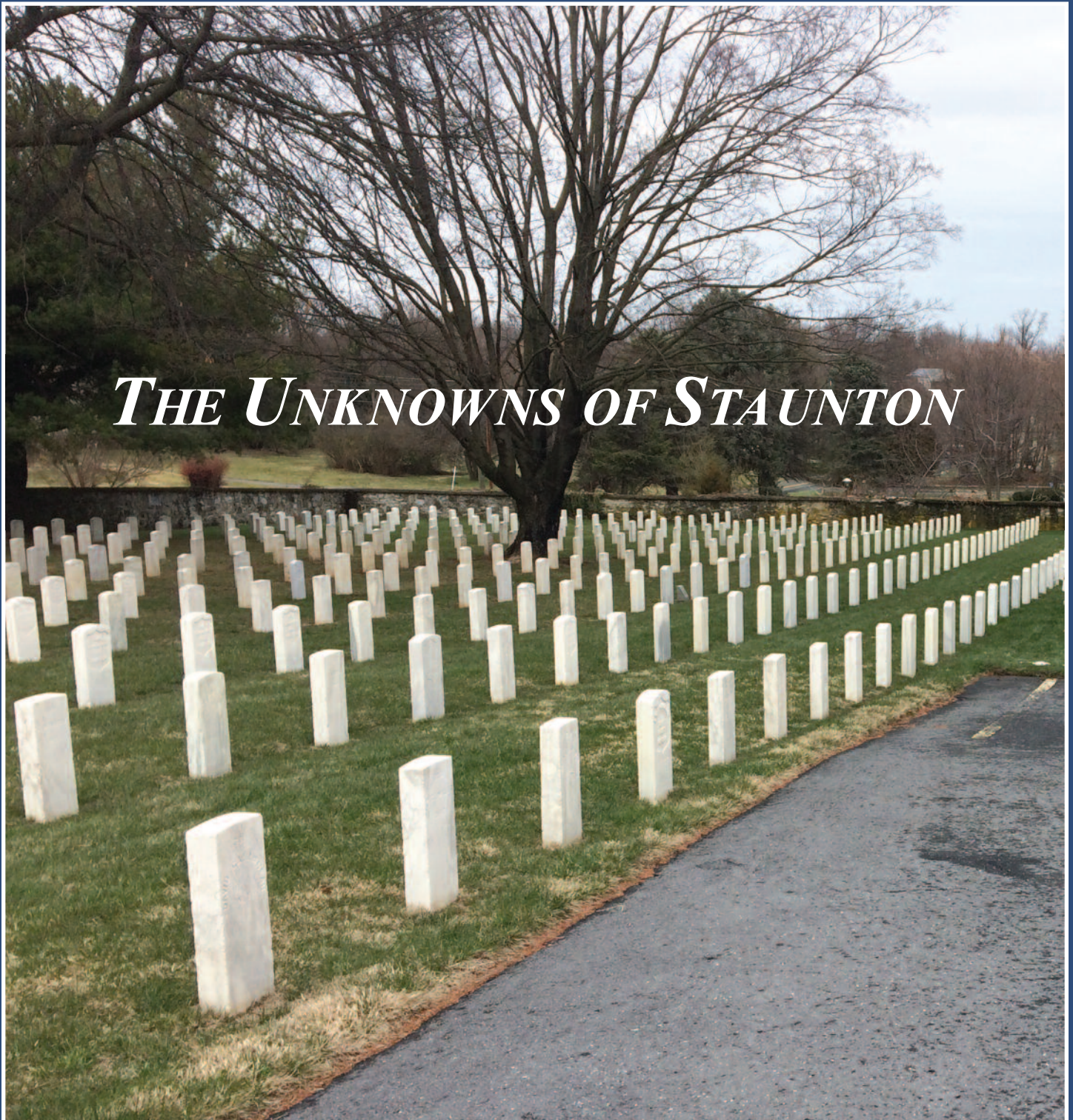

Synopsis of General Orders issued by Commander-in-Chief Mark Day. The complete Order can be viewed on the Order's website.

GENERAL ORDER #24:

The Department Encampment is the administrative ruling body for the Department, while in session. While Chapter II Article VII, Section 1b of the C&R states that the Department Commander shall preside at all meetings of the Department Encampment, and appoint all standing and other committees, this does not supersede or negate the power of the Department Encampment to direct the formation and membership of such committees it see necessary, within the confines of the rules prescribed in the Departments By-laws or Constitution and Regulations of the Sons of Union Veterans of the Civil War.

GENERAL ORDER #25:

Reports the resignation of James Crane (Ohio) from the National Encampment Site Committee and appoints Michael Paquette (Chesapeake) to that committee.

GENERAL ORDER #26:

Reports the brothers of the William T. Sherman/Billy Yank Camp #65, Department of Missouri voluntarily surrendered their Charter after more than 35 years faithful service, all brothers receiving transfer cards.

GENERAL ORDER #27:

Announcing the awarding of the Meritorious Service Award with Gold Star to Gene Turner, PDC, Department of Oklahoma.

GENERAL ORDER #28:

Orders the revocation of the Charters of both the Luray-Carlisle Reunion Camp #1881 and the Charles Sumner Camp #25, Department of the Chesapeake.

GENERAL ORDER #29:

Announcing the awarding of the Dr. Mary Walker Award to Sister Carolyn Dyer, Department of Illinois, Auxiliary to the Sons of Union Veterans of the Civil War.

GENERAL ORDER #30:

Announcing the 2018 Scholarship recipients: Barrett Ean Young, Humboldt Camp #9, Department of Kansas and John A. Palmer, Ulysses Grant Camp #68, Department of Missouri.

GENERAL ORDER #31:

Commemorates the 150th anniversary of General Order #11 and the first Memorial Day observance at Arlington National Cemetery.

**OPEN ITEMS FROM POST 2017 Lansing,
Michigan National Encampment CofA Meeting**

National Encampment.

Motion by Brian Pierson for seed money to the Host Department be increased to minimum of \$3,500 starting 2018 encampment, passed. The LGAR has pulled out of 2018 National Encampment, still in talks with Auxiliary for future National Encampments.

National Signals Officer; James P. McGuire.

Still working with the Website and Social Media Census Committee.

National Treasurer: David McReynolds.

Still working on an "information systems and financial records disaster contingency plan". The National Treasurer will be using Quick Books and the cloud

Senior Vice Commander-in-Chief Shaw

The P&P will be making necessary corrections to the form 50, remove inconsistencies and create a proper sequence of events.

From the National Treasurer as a Recommendation:

CinC & CofA members who receive an advance should submit all receipts to support an advance or refund the unused portion in a timely manner. Proposed language will be submitted to the C&R committee for study.

Veterans Administration Booklet

Still pending inclusion of the Order in this publication.

National Treasurer Additional Reporting

Once a few items are completed, the National Treasurer will re-apply to the IRS for a Group Exemption for the Departments and Camps.

**FROM 2017 LANSING, MICHIGAN ENCAMPMENT
RECOMMENDATIONS**

National Signals Officer & Webmaster: James P. McGuire, DC

Engage a professional firm who can conduct the process of "discovery" in order to determine what our

needs for a new website are, so that we can make an informed decision regarding what we need when it comes time to get quotes for a new site. This is deferred for the time being.

Assistant National Quartermaster: George Shadman

Based upon his recommendation, motion by Donald Martin, PCinC, seconded by Nat. QM Danny Wheeler to limit the ROTC award to one medal per branch per year, per school.

P&P Committee to look at Form 7 and make some revisions.

National Committee on Civil War Memorial Grant Fund: Brian C. Pierson, PDC

Still evaluating whether grant eligibility should be expanded to include GAR halls, historical GAR furniture and decorations, and if so, define specific criteria, standards and restrictions for these items

National Committee on Vision and Planning: Brian C. Pierson, PDC

Continuing to revamp the recruiting and retention program and develop a strategy to reduce drops. We appear to be recruiting, but not retaining members.

Engagement

Pending: Assist Departments and Camps in school engagement, perhaps with a standardized kit.

The Battle Flag Preservation program needs to develop a vision, strategy, goals and objectives. This will be submitted to the C&R committee for consideration.

The CinC to appoint a Temporary Committee to study the issue of establishing a National Battlefield Preservation Program or assign this responsibility to an existing committee. Marketing & Promotion Committee continuing to evaluate the effectiveness of the strategy.

Recently I went to a meeting of the very first Civil War Round Table - Chicago. The speaker was an author who had done a tremendous amount of research on U.S. Grant for his book. As his presentation unfolded, it appeared that he had approached The General from a "Lost Cause" point of view - so much so that by the end of his presentation I, and many other students of the Recent Unpleasantness had to ask - how could the Union have won with such terrible leadership? Here were 40 people in a room who have been studying the Civil War for decades, confronting a man who had a point of view completely foreign to their own. However, they did not tear him to pieces, but they could have. They did not ridicule him and point out his faulty conclusions, but they could have. Instead, they treated him with respect and sought merely to have him clarify some of his erroneous statements.

The lessons I learned from this experience were:

- Everyone deserves respect.
- Attacking someone with an opposing view accomplishes nothing good
- There are people in my life who can teach me valuable lessons, and one of them is to smile and keep my mouth shut.

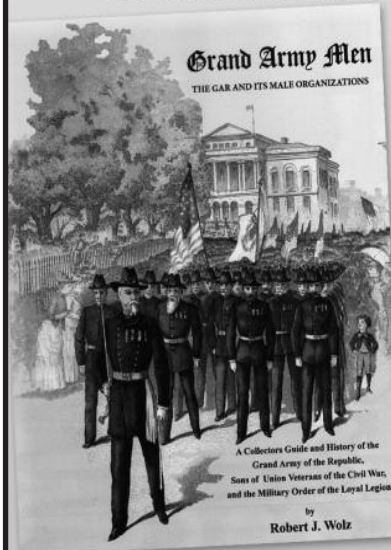

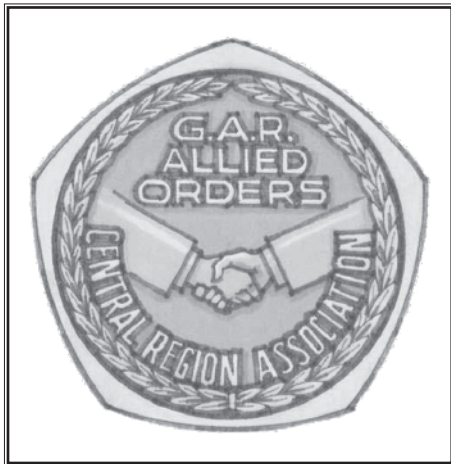

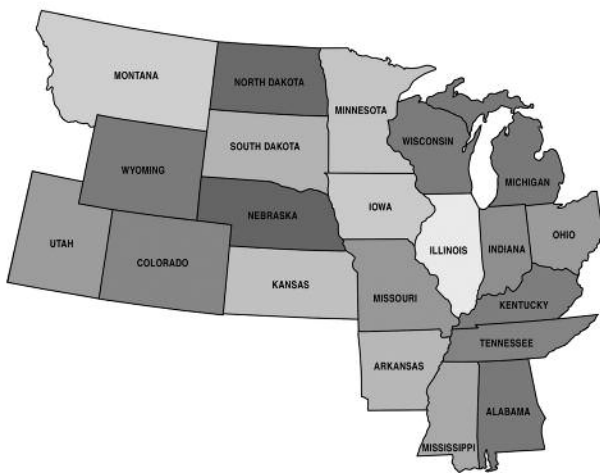
CENTRAL REGION ASSOCIATION CONFERENCE OCT 5-6, 2018

Veterans - A survey has been completed to determine how many brothers of the Order are veterans.

JVCinC - Recommends the membership application forms indicate that the Part V relationships be circled or a check box be added. Also, a new application process is being studied for applications received by the JVCinC.

The above process will be forwarded to the C&R committee once completed.

RECOMMENDATIONS FROM 2017 LANSING, MICHIGAN REPORTS:

National Committee on GAR Records and the National GAR Records Officer Dean Enderlin, PCC:

Revision of form 49 (Certification of Election and Installation of Department Officers) be updated to include the required office of Department GAR Records Officer. Plus a version of a modified fill-in Adobe Acrobat PDF form, which has been provided to the Commander-in-Chief and the Chair of the National Committee on Program & Policy for their review.

2017 GETTYSBURG, PENNSYLVANIA COFA MEETING NEW BUSINESS:

Kevin Tucker to recommend committee on customs and curtsies at a National Encampment.

Proposed by Brother David McReynolds and second Brother Kevin Tucker second to continue contract for three year with Executive Director David Demmy. Motion carried.

Motion by Brother Martin, seconded by Brother Paquette to leave intact Charitable Foundation licensing till post 2018 encampment. Motion passed.

RECOMMENDATIONS FROM 2018 BRENTWOOD, TENNESSEE SPRING REPORTS:

Recommendation for language to be added to the Order's Ritual & Ceremonies. (Ed. Note: unclear which committee made recommendations for alterations, or what those items were.)

Motion by Council of Administration Member Brian Pierson accepting recommendation from Brother James Pahl that National Treasurer look if stipend for the National Chaplain may be found within the 2019 National Budget, seconded by National Quartermaster Danny Wheeler. Motion passed.

From the National Committee on Fraternal Relations, Kevin L. Martin, PDC a recommendation the National Encampment Site Committee Chair establish a line of communication with the DUVCW for the formation of joint Conventions/Encampments starting in 2021. Moved National Treasurer McReynolds will review budget for items currently within budget that relate to the Fraternal

Relations Committee and report back to the CofA. Passed by 6 to 3 vote.

From the National Committee on Program and Policy, Donald W. Shaw, PDC, that the Council issue letters of thanks to the two individuals who donated time and talent to fixing the problems we had with the calculation features on the Form 27; David Wallace, PDC and Robbie Gifford, Technology Coordinator for Michigan's 7th Judicial Circuit Court. Motion made, seconded and passed.

NEW BUSINESS:

Brother David Hann of the Department of New Jersey requested \$150.00 to purchase a SUVCW banner for a National Recruiting Tent during the 155th Gettysburg Battle and Remembrance Day Event. National Treasurer David McReynolds recommended funds be expended from Special Project Fund. Council of Administration Member Brian Pierson moved that recommendation be accepted, Council of Administration Member Edward Norris seconded. Motion passed.

GOOD OF THE ORDER:

Don Martin, PCinC, passed out flyer on project to restore Joshua Sill Monument. Motion by CofA Member Brian Pierson to spend \$2850 from special project fund to cover, seconded by CofA Member Kevin Tucker. Motion Passed.

Brian Pierson noted that Gene Turner, PDC is in poor health, recommended that Meritorious Service award with Gold Star be considered.

Motion by CofA Member Don Martin that Commander-in-Chief's expense fund to be raised to \$15,000, to be inclusive for this current year, seconded by CofA Member Michael Paquette. National Treasurer David McReynolds asked this be amended to raise National Treasurer and National Secretary to \$5,000 each. Accepted by Brother Martin and Brother Paquette. Motion Passed with one (1) abstaining.

CinC Day will be spending Memorial Day laying a wreath for the 150th anniversary of General Logan's General Order #11 in Washington D.C.

Walking among the graves of fallen Union Soldiers and Sailors on Memorial Day Weekend has always reminded me of the PAIN the Boys in Blue went through to keep our Nation together. The psychological and physical pain must have been tremendous. I know that at times I can honestly say "Nothing Hurts," but there are other times when the pain and discomfort are agonizing. CHESAPEAKE

ELLCOTT CITY, MD (April 28, 2018) – The Department gathered at the Turf Valley Resort in historic Ellicott City, MD on April 27 and 28 to attend the 131st annual Encampment of the Department of the Chesapeake. The brothers were joined by the Auxiliary and special guests, CinC Mark Day, Auxiliary National President Ramona A. Greenwalt and also PNP Rachelle Campbell.

Early arrivals on Friday were treated to a special afternoon tour of the perfectly preserved first railroad station in our country that features exhibits highlighting the transportation system's crucial role in the Civil War. They then stopped by for a repast at the Trolley Stop, a tavern dating to 1833, followed by a communal meal at the nearby White Oak Tavern.



Encampment sessions included receipt of an extraordinary Citation from Governor Larry Hogan, presented by Maryland's Secretary of Veterans Affairs, Mr. George W. Owings, III. Secretary Owings bestowed a special keepsake pin and certificate to veterans in attendance.

For 113 years, the congregation of Lansdowne Christian Church in Baltimore's Halethorpe community has faithfully paid an annual tribute to the Grand Army of the Republic (GAR) during a special Memorial Day weekend service. This year, Brothers of Baltimore-based James A. Garfield Camp No. 1 played a key role in helping the church conduct its service, including a reading of "When the Boys in Blue are Gone" and a powerful tribute to the GAR that was themed, "Uncommon Deeds by Common Men".

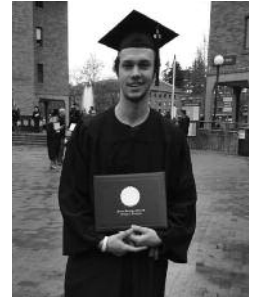


The Lansdowne Christian Church, also known as Hull Memorial, was donated in 1903 by Private Charles Wesley Hull (Co. L, 1st Ohio Heavy Artillery) and his

wife Mary Bumley Hull to honor his Union Army comrades and features three beautiful stained-glass windows given by the GAR, Dushane Post # 3 (where Hull served as commander) and the Women's Relief Corps. It is the only church in the United States dedicated to the memory of the GAR.

COLUMBIA

Darren Chromey, 25, a member of Gov. Isaac Stevens Camp #1, Dept. of the Columbia, graduated from Western Washington University, Bellingham, WA, on March 24, 2018, with a BA degree in Geography. Darren joined SUVCW at age 8 and is an Eagle Scout.



CONNECTICUT

On April 7th 2018 member of Colonel William B. Wooster – Colonel Charles L. Russell Camp No. 22 together with Town of Greenwich, Greenwich Historical Society, Greenwich Veterans Council, Boys and Girls Club and Scouts rededicated the G.A.R. Monument in Greenwich, Ct. The monument was originally placed in front of the Town School building on April 9th 1914 along with a tree planted at the time. After 104 years, the tree decided to join our Civil War veterans and a replacement had to be found. Hardscrabble Farms of North Salem N.Y. located a similar tree and donated it to the cause.



The rededication followed the same procedure as 104 years ago in as much as the Camp planted the tree, passed it onto the Town and Board of Education with the Town's commitment the tree will be a constant reminder of the heroism and sacrifices given to preserve the Union for future generations. During the Civil War, some 450 men of Greenwich answered the call and at least 69 paid the ultimate price.

FLORIDA

The Department of Florida held its 23rd Annual Encampment March 10th in St. Cloud, Florida. St. Cloud is one of three GAR Sponsored Communities within the State of Florida. SVCinC Don Shaw was able to attend.

DEPARTMENT NEWS

The group toured Historic St. Cloud including Mt. Peace Cemetery where 450 Union Veterans are buried and the GAR (Post #34) Hall built in 1914.



On 2 May, 2018, brothers of Frederick R. Jackson Camp # 7, Pembroke Pines, FL, presented Special Commendations to three JROTC Cadets who were wounded during the shooting at Marjory Stoneman Douglas High School in Parkland, FL in February. This Commendation FOR PATRIOTISM AND SACRIFICE was recommended by Camp 7 and authorized by the Department Commander.



Those awards were a part of the Joint Awards Ceremony at the Parkland High School, organized by the High School ROTC and were attended by representatives from several military organizations in South Florida. On March 24th, Brothers from General James B. McPherson Camp #1 and Kennesaw Mountain Camp #3, Department of Georgia and South Carolina, gathered at Evergreen Cemetery in Fitzgerald, Georgia to clean military headstones. The Brothers cleaned several hundred Union headstones as well as headstones of Confederate, Spanish American, World War I and World War II veterans. Fitzgerald was developed in 1895 by Philander H. Fitzgerald, an Indianapolis newspaper editor and a former drummer boy in the Union Army who founded it as a community for Union and Confederate Civil War veterans.

NEW YORK

Members of the Richard J Clark Camp No. 210 served as Color Guard in a ceremony honoring Captain Samuel Chester Reid at Green Wood Cemetery in Brooklyn. Captain Reid, who distinguished himself in the War of 1812 commanding the privateer the "General Armstrong," assisted General Jackson in the defense of New Orleans.



After the War of 1812, Captain Reid assisted in standardizing the design of the flag in 1818, replacing the 15 stripes of the Star-Spangled Banner with 13 stripes and adding a star for each new state entering the Union. The Flag Act of 1818 solidified the American Flag as we know it today.



The Col. George L. Willard Camp #154, Department of New York, adopted the Kellogg Family Plot and General Thomas gravesite in 2012. The following year the Camp completed a memorandum of agreement with the Friends of Oakwood Cemetery Troy NY, Inc. and Oakwood Cemetery to support the maintenance of the plot and gravesite. Since that time we have contributed directional signage and a site marker to the General Thomas site. Cooperation among our Brothers resulted in a concerted effort to help remove the beech tree that has rained down large limbs and small branches onto the Kellogg family plot that contains the General Thomas monument, destroying much of the original fencing.

Brothers of the Camp joined Bernie Vogel, Chief Administrator of Oakwood Cemetery and the tree removal crew early in the morning. One surprise that required attention was an active nest of hornets that needed to be cleared from the plot for the safety of the workers. With a crane emplaced, an arborist was hoisted to the tree and the first limb was removed. After two hours a truckload of wood was removed to a safe place, with the tree finally felled in the early afternoon.

Willard Camp provided for about one-third of the cost of the tree removal. Remaining is the repair and rebuilding of the original iron perimeter fence and gate. The damaged sections have all been carefully stored for use during rehabilitation of the fence and entry gate. Quotes are being obtained by Oakwood Cemetery for the work needed. The Camp is raising funds through the sales of the General Thomas challenge coin. Further information can be found on the Camp's web site.

In 1865, Privates William T. Bradley, Henry P. Evans and John E. Maricle were serving in the 2nd North Carolina Infantry (U.S.) and participated in a support role in Stoneman's Raid of 1865. By the time these three men arrived in Boone, all were ill and died in April 1865 in the Union field hospital there. They were interred in what was then known as the "Councill Cemetery" in a part later known as the "black" section of the Boone Cemetery.



The military headstones on their graves had been damaged and stolen in the 1990's. Recently, the Town of Boone and their Historic Preservation Commission replaced the military headstones and asked our Camp to perform the Headstone Rededication Service.

OKLAHOMA



At the Department of Oklahoma's Annual Encampment at Fort Gibson, OK, Brother Norman Crowe, a member of the Cherokee Nation of Oklahoma presented a handcrafted tomahawk gavel to the Department. Outgoing Department Commander Rex Griffon accepted

the gift on behalf of the Department. Two of Brother Crowe's great-great grandfathers and five uncles, all members of the Cherokee Nation, served in the 3rd Indian Home Guard (US) during the Civil War and were stationed at one time or another at Fort Gibson, Indian Territory.

PENNSYLVANIA

The May meeting of Isaac Eaton Camp No. 504 was a real treat for the brothers. Brother John Chamberlin Reed III displayed the rifle his great-great grandfather carried at the Battle of Gettysburg as a member of the 102nd PA Vol. Inf. The rifle has been handed down through the family. The rifle was a completely original Springfield Model 42, .69 cal rifled musket with a Maynard tape primer conversion dated 1857.



A Memorial Observance and Wreath laying was held for Pres. Lincoln at the Lincoln Monument in Nay Aug Park, Scranton, PA on 4/21/18 by the Lt. Ezra Griffin Camp #8 and Scranton's Auxiliary #10. They were joined by Boy Scouts from Dickson City PA.

RHODE ISLAND

The Department of Rhode Island is celebrating the 150th anniversary of the organization of the Department of Rhode Island, Grand Army of the Republic. Officially organized on March 24, 1868, the RIGAR's first elected Department Commander was General Ambrose E. Burnside. In honor of our ancestors, the RISUVCW has planned a yearlong slate of events. The Department has also struck a commemorative medal that was distributed to all attendees at the Department's Annual Awards Dinner on the eve of the RISUVCW 134th Annual Encampment.



The Department also developed a traveling library display that is rotating through libraries throughout Rhode Island with artifacts from and information about the RIGAR and its stories history.

The Department was also featured in the pregame ceremonies at the Pawtucket Red Sox (AAA affiliate of the Boston Red Sox) where members of the Department presented the colors, were interviewed on-air by the broadcast team and Department Commander Jamie McGuire delivered the ceremonial first pitch prior to the game.



The Brothers of Major Sullivan Ballou Camp #3 have been hard at work at the Rodman Family Plot in South Kingstown. McTeer Camp No. 39 of the Sons of Union Veterans of the Civil War (SUVCW) had the distinct honor to dedicate the headstone of a distinguished Civil War veteran, Celso Pierucci at the Old Grey Cemetery in downtown Knoxville. This cemetery occupies 13 acres and was founded in 1850. Today, Old Gray clearly depicts Knoxville's history and provides an important example of cemetery planning and design during the rural cemetery or garden movement.

Participating in the ceremony was great-grandson Larry Pierucci and his wife Benita, Theresa Conway and Cousin Don Russell. Also participating was the color guard from the



William Blount High School Air Force Junior ROTC and Boy Scouts from Troop 800 in Maryville.

WISCONSIN

Isaiah Ryan was buried in the Oak Hill Cemetery in Lake Geneva in 1941, being 93 years of age, making him the last Civil War soldier buried in Walworth County. Ryan served as a dispatch rider in the 193rd New York Infantry in the last year of the Civil War.

Joining with Camp 15 were sisters of the Mary Chesebro Lee Tent #23, DUVCW; W.H. Bennett Women's Relief Corps #71 and the Ladies Auxiliary 4 of the Sons of Union Veterans.

HISTORY OF THE SONS

BY BOB WOLZ, NATIONAL HISTORIAN

THE FIRST SUCCESSFUL SONS

Comrade James P. Holt of Philadelphia's Anna Ross Post 94, Dept. of Pennsylvania, Grand Army of the Republic, made a motion on August 27, 1878 proposing the formation of a cadet corps consisting of their sons to aid in Memorial Day observance. The Post appointed a committee consisting of Comrades Levy Shengle, Carl Frederick, Charles Weiss, William Morgan and James Holt to further investigate the proposal.

On Sept 17 this committee came back with a plan for organization, sample constitution, charter and application form. A week later on Sept 29 Anna M Ross Cadet Corps # 1 was established. At first, the officers were Grand Army men with their sons forming the membership. Lewis Vandergrift was elected the first youth officer of Anna M Ross Cadet Corps. Post 51 of Philadelphia formed the second Cadet Corps and the concept spread quickly throughout eastern Pennsylvania. A membership badge was produced. Perhaps because of their short life or funding problems, no lapel buttons or uniforms have been found.

In July 1880, the first state organization or Division formed with Conrad Linder elected Division Commander with the rank of Colonel. Additional Cadet Corps formed in New York, New Jersey and Delaware and a National Organization was effected in 1881. Likewise in 1884, the sons in New England headed by Comrade Edwin Earp of Lynn Post # 5 of the Massachusetts G.A.R., affiliated his 34 chapters of sons with these Philadelphia Cadet Corps.

With this national growth came a lot of financial instability. Chapters began abandoning the Cadet Corps organization between 1886 and 1889 and affiliated with Major AP Davis' Sons of Veterans, USA headquartered in Pittsburgh. Under the terms of merger Anna M. Ross Cadet Corps became Anna M. Ross Camp # 1 and Davis Camp # 1 of Pittsburgh replaced their number with a "star" identifying them as the Charter Camp of our Order.
